### **Pre-Production Testing and limited Warranty Sign-off**

By and large it is only a good idea to plan to purchase if the end user enjoys mechanical activities and plans to do the initial set-up. Please do not plan on any help from the Dealer in any way or form, this program works best if the extra discount means enough to the end user so he wants to do his own set-up/repairs if needed.

The Manufacturer (Baumalight by MTB Mfg Inc) understands that the proposed offer will not suit every Purchaser (End User) or Dealer/Distributor so if the Dealer/Distributor would rather we just sell direct to the end user then we can do that if we have written encouragement from the Dealer/Distributor.

The Manufacturer will make every effort to supply a product of the same value as a Full Production Model, but the Purchaser needs to understand and acknowledge that they know the supplied product is still in a stage of design, manufacturing and testing. Due to this, certain issues and complications in set-up or defects in operation cannot be found until after a product is used in a work environment only a Purchaser could provide.

In exchange for the Purchaser's agreement to the below, the Manufacturer will extend a discount off the list price of the product as advertised online and this discount is intended to be passed through the dealer to the end user.

The agreed upon warranty would be as follows:

1. Any parts required would be fully covered (including standard shipping/freight to non-remote areas) by the Manufacturer for a term of 1 year from date of purchase
  - a. If a new frame is required, then the Manufacturer would send it at no charge but the Purchaser would have to un-bolt and re-bolt any and all bolt-on parts. Repairs by welding while under warranty are rarely asked to be performed as the manufacturer wants to design a frame that does the job
2. The Manufacturer will not be held liable for any loss of time or earnings
3. The Purchaser understands that lead time for replacement items may be lengthy
4. The Purchaser understands that any labor work as it relates to repairs, updates or any other situation would not be covered under any circumstances by the Manufacturer.
  - a. The Purchaser agrees that they will perform any labor required themselves or at their own expense
  - b. The Dealer (Re-Seller) is not required to perform any labor under any circumstance and agrees to never charge back any labor charges to the Manufacturer under any circumstance including but not limited to damage during shipping, setup or manufacturing
5. The Manufacturer is not liable for any damage to Carrier Equipment caused by installation or use of the Pre-Production Unit.
6. The Reseller understands that any labor work done at any time is in violation of this agreement and acknowledges that under no circumstances will they look to the manufacture for compensation for any possible reason or scenario.

The undersigned Purchaser has reviewed and accepted the terms of warranty in regards to Pre-Production Models provided by the Manufacturer.
